Traveling to Columbus

Port Columbus International Airport, located just 15 minutes from the Hilton Columbus Downtown, is served by 10 airlines and their regional affiliates, providing 350 daily arrivals and departures serving 35 destinations on a non-stop basis and hundreds of additional cities on a direct or connecting basis.
